Mr. Dutton obtained his doctorate of law from Ohio Northern University, Pettit College of Law in 1984. During his course of study at Ohio Northern University, Mr. Dutton was a member of the editorial staff of the Ohio Northern University Law Review. He was also a justice on the law school's Moot Court Executive Board, and was the justice in charge of the First Year Appellate Advocacy Program. While in law school Mr. Dutton also participated in four national moot court competitions, including the Fall National Moot Court Competition, the Phillip C. Jessup International Law Moot Court Competition (Best Written Memorial), the Benton Privacy Law Competition (Team Coach) and the American Bar Association Client Counseling Competition. Because of his moot court experience, he was selected to the Order of Barristers for having exhibited excellence and obtained high honor through the art of courtroom advocacy.

Additional achievements by Mr. Dutton while in law school included the authorship and publication of an article on constitutional law that has been published nationally, selection as research assistant to Professor Paul Edwards, and participation on the faculty hiring committee.
